



Notice of vegetation work – Quinton Road

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance.

Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What will we be doing?

Ahead of the main construction works in the area around Quinton Road, we need to carry out ecology surveys and vegetation / tree clearance along the highway boundary. As some of these works will need to be carried out on or adjacent to the carriageway we will need to put in place two-way temporary traffic lights between 9.30 and – 3pm, the road will open as normal outside of these times.

The works will take place between 26 – 28 April 2021.

Please refer to the map overleaf that shows the working areas.

To reduce the impact of these works, the works previously advertised on Fiddlers Field Road during April have been postponed and there will only be a full one day closure on the 29 April 2021, 8am to 5pm. These survey works have been co-ordinated with the works on Quinton Road to limit the impact to the local community. Further works are still required on Fiddlers Field Road and we will keep you updated.

How will this affect you?

For the safety of road users and personnel involved with the works, we will need to implement a lane closure and use temporary traffic signals to manage traffic on Quinton Road. The lane closure will be managed by two way traffic lights which will be required for up to three days. To minimise the disruption to the community and motorists we will be carrying out this work between the hours of 9:30am and 3pm. Outside of these hours the road will be open as normal.

Roadside advance warning messaging signs will be in place prior and during the works to alert road users.

To allow us to work on vegetation close to the highway, and to protect all road users, from possible falling debris, we will at times need to implement a temporary hold on all road users. This hold will last no longer than 15 minutes and will occur no more than once a day.

The vegetation clearance will generate low levels of noise. We will continue to work hard to ensure that any impacts on residents are kept to a minimum during these works.

What consents do we have to undertake this work?

There have been extensive ecological and tree surveys undertaken for the areas identified for clearance. Before any hedgerow or trees are cleared the area will be thoroughly inspected by qualified ecologists. Any protected species found to be present will be recorded and no vegetation will be cleared until the species have left the site, this includes nesting birds.

Hedgerow cutting works are undertaken under the instructions of the ecologist on site. The ecologist decides the appropriate methods based on the vegetation present. This involves a detailed hand search to determine if any ecology is present. If it is found that the area is clear, then the works will be allowed to take place. A small workforce will use machinery and hand-held equipment to clear the hedgerow and trees. Vegetation will be cut down to just above ground level followed by stump removal.

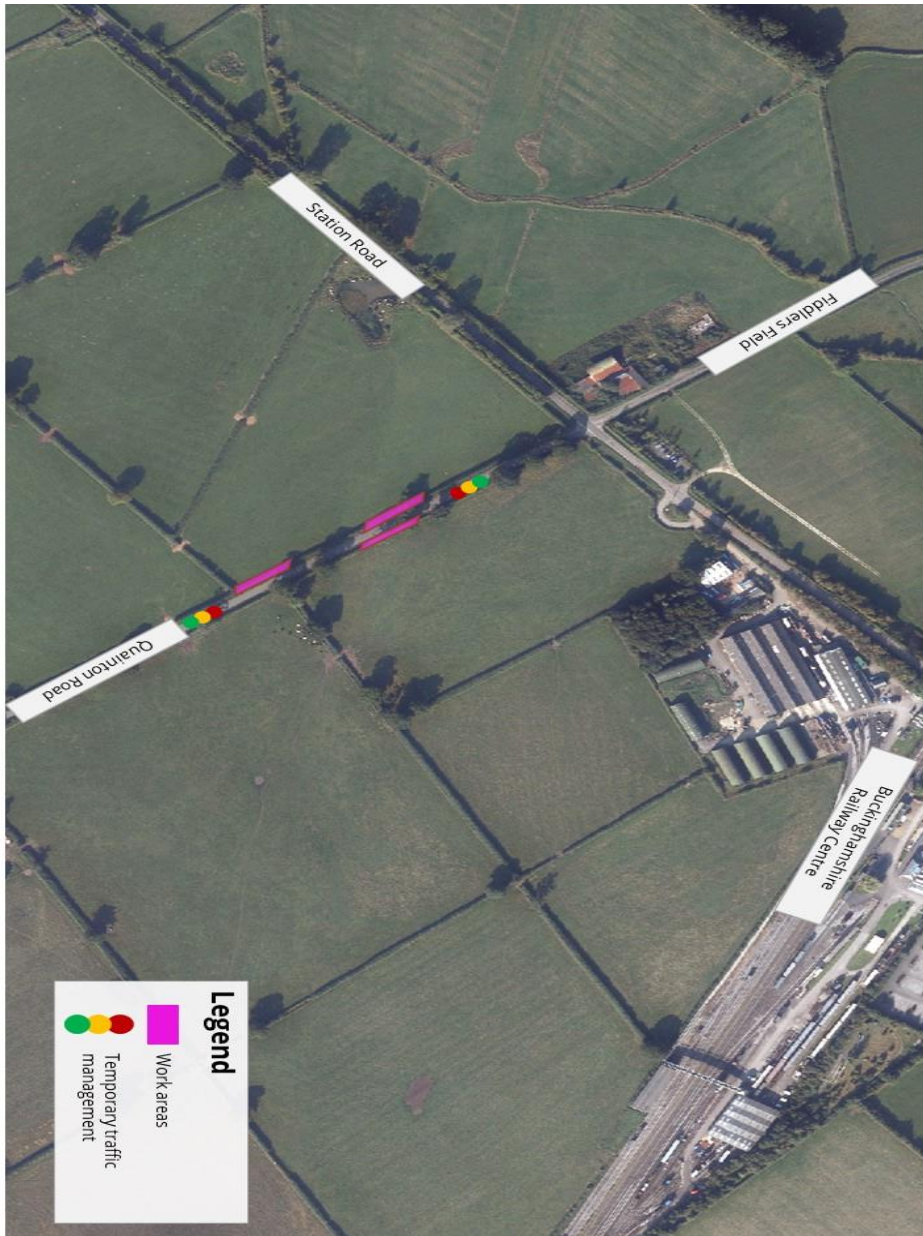
